General Guidelines in the conduct of the Regional Search for Brigada Eskwela Best Implementing Schools

- 1. All entries for regional evaluation shall be endorsed by the SDS.
- 2. Top 5 Schools in the regional evaluation of the documents shall be evaluated and validated on-site to determine the 1st, 2nd and 3rd Place Winners.
- 3. The following shall be observed during the evaluation:
 - a. Opening Program (15-20 minutes)
 - b. Evaluation by Component (1 Hr)
 - c. Exit Conference (30 minutes)
- 4. Classes shall not be disrupted during the evaluation. Extravagant preparations, carnivals and loud sound music (music, drum, bugle) are prohibited during the evaluation.
