

Preparations for SBFP implementation for SY 2016 ~ 2017 are underway such as drafting of implementing guidelines and finalization of the number of beneficiaries for the downloading of funds. This is to ensure that the feeding program will commence as early as July 2016 to enable schools to complete the 120 feeding days by December.

In this connection, all regions and divisions are hereby directed to submit a status report on SBFP covering the 40 days and 80 days feeding, respectively. Likewise, we request a report on the divisions/schools that adopted the various feeding modalities incorporated in the guidelines for SY 2015 ~ 2016.
