

GROUND RULES

I. COMPOSITION OF A TEAM

A team is composed of maximum of:

1.1

15 Players line-up all to play

1 Head Coach

1 Assistant Coach / Trainer

1 Utility

1 Team Manager

II. SYSTEM OF COMPETITION

In case the participating Teams are seven (7) or less

All teams will play against east other in a single round robin system to decide the

The semi-finals and final round will be played in a page-system format.

In case the participating Teams are eight (8) or more

The teams will be divided in two (2) or three (3) preliminary groups (A & B & C). In each group, the teams will play against each other in a single round robin elimination system. In the finals, the first and second ranked teams in each group will play crossover system (A1 vs B2, B1 vs A2). Then the winning teams will play against each other for the first and second place while the losers will play for the 3rd and 4th. In the similar way, the ranking for the 5th to 8th place will be decided.

III. RANKING SYSTEM

3.1		

The following points shall be taken into account to decide the rankings

		WINNER	LOSE
MATCH WON	(3:0)	3 points	0
MATCH WON	(3:1)	3 points	1
MATCH WON	(3:2)	3 points	2

3.2

If two (2) or more teams obtain the same points, the ranking shall be decided by the quotient of the whole sets won and lost.

3.3

If they again score equal, the ranking will be decided by the quotient of the points won and lost for the whole matches.

3.4

If two teams are still equal, priority shall be given to a team according to the results of the match played between the two teams concerned (Winner Over the Other Rule).

IV. LIBERO DEFENSIVE PLAYERS (Art 12.6.4)

4.1

One (1) or two (2) Libero Defensive Player/s may be applied and can be changed every match.

V. OFFICIAL BALL

The 2ND CONFERENCE 2016 NIRVF INTER-OFFICE EMPLOYEES VOLLEYBALL TOURNAMENT will be played with MIKASA MV 300 / 200 #5.

VI. THE CONTROL COMMITTEE

The 2016 NIRVF INTER-OFFICE EMPLOYEES VOLLEYBALL TOURNAMENT shall be directed by the Control Committee presided by the Tournament Chairman.

VII. OFFICIATING

Accredited PVF-NORVA Officials will handle the officiating.

VIII. AWARDING

Championship Cup / Trophies will be awarded to the first four (4) teams. Special Individual Awards will also be given to Outstanding and deserving players.

IX. VOLUNTARY FORFEITURE

Any team/s that withdraw / walk-out voluntarily from the match shall be eliminated form the whole competition and the results already obtained at all stages will be cancelled. From the moment of withdrawal / exclusions, all expenses involved shall be charged to the team involved, other sanctions shall be made by the Organizer.

X. PLAYING PROTOCOL

The specific Playing Protocol of this tournament will be carried out in accordance with the FIVB & PVF traditions. The details of the Playing Protocol shall be decided by the Organizing Committee.

XI. PROTEST

Protest on eligibility of players shall be entertained only before and during the elimination round. **NO PROTEST** on eligibility will be entertained during the Championship round.

XII. MISCELLANEOUS

All matters not mentioned in this Regulation shall be decided by the NIRVF Control Committee Chairman.
