The immunization program has focused on the provision of free vaccines for infants since 1975. However, protection provided by some of these vaccines will decline over time and booster doses are required to ensure high levels of protection are maintained, thus, it is important that health service providers take every available opportunity to deliver vaccines and start vaccination for the school children and adolescents enrolled.

The Department of Health (DOH), in collaboration with the Department of Education (DepEd) and the Department of the Interior and Local Government (DILG) will conduct a **School-Based Immunization in the whole month of August 2016**. The objective of the activity is to immunize school children enrolled in Grade 1 and Grade 7 with Measles Containing Vaccine (MCV), Tetanus-Diphtheria (Td) and Measles Rubella (MR) as an integral immunization strategy towards elimination of measles, tetanus and the control of rubella and diphtheria.

To ensure that Region 7 will be able to achieve the 95% target, may we request your good office to prioritize the School-Based Immunization Activity and support the Vaccination Team from the LGUs.
