With regard to PPSII, Insurance Commissioner Emmannuel F. Dooc requested DepEd to implement the following effective immediately:

- 1. Discontinue the deduction of PPSII insurance premium from the salaries of the concerned DepEd personnel;
- 2. Cancel the outstanding checks issued to PPSII intended for insurance premiums and return to the DepEd personnel concerned the corresponding amount deducted from their salaries;

We acknowledge receipt of copy of your letter dated February 25, 2015 addressed to Atty. Roehl Galandines, then Conservator of Philippine Phoenix Surety and Insurance, Inc. (now Liquidator) which your Ms. Marites Rea, Administrative Officer IV, furnished us. We noted the following information from your said letter

- Philippine Phoenix Surety and Insurance, Inc. (PPSII) has been accredited with the Department's Automatic Payroll Deduction System (APDS) under APDS Code Nos. 0207 and 0217, engaging in insurance and lending businesses with DepEd personnel in Regions VI and National Capital Region (NCR).
- There are seventy-six DepEd employees from Regions VI and NCR who have existing insurance memberships with PPSII;

Ms. Rea advised us that you have not as yet received a reply from Atty. Galandines. Hence, we wish to advise that Philippine Phoenix Surety and Insurance, Inc. (PPSII, for brevity) is currently under liquidation by Atty. Roehl Galandines, as Liquidator

May we be furnished with copy of the listing of the seventy-six (76) DepEd employees from Regions Vi and NCR that have existing insurance memberships with the said company.

Concerning your intention to issue directives to the concerned regions for the stoppage of the deductions from the salaries of the concerned DepEd members, may we suggest that a meeting be held among your authorized representatives, those of PPSII and this Commission for the purpose of clarifying certain matters. 
