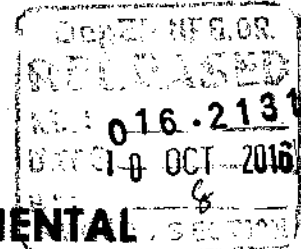

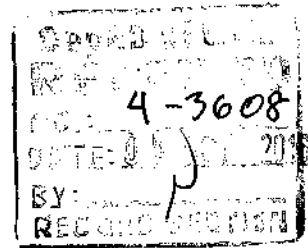
SUBJECT: 2016 BUGLASAN ORGANIC FARM FAMILY AND BLAIDES CONGRESS
